**Exhibitor Agreement**

This Exhibitor Agreement (“Agreement”) for the 2009 Options Industry Conference (“Event”) is between the Boston Options Exchange Group, LLC (“BOX”) and the Exhibitor (“Exhibitor”) named below, and shall upon receipt of the payment for the Exhibit Fee constitute a valid and binding contract. The terms and conditions outlined herein shall govern this relationship and may be supplemented by the Exhibitor Services Package, which will be delivered at a later date.

**Exhibit Fee Includes:**

- One complimentary registration to all Event programs.
- Company name, logo and description included in all Event materials.
- Complimentary color advertisement in Event program.
- Detailed company listing on Event website with logo, web link, contact info, and company description.

**Cancellation**

In the event that Exhibitor provides BOX with notice of intent to cancel its exhibit at the Event, and such notice is received by BOX in writing on or before February 13, 2009, BOX will refund to Exhibitor all sums paid, less a cancellation fee of \$1,000 per booth. Any cancellation by Exhibitor received by BOX after February 13, 2009 will result in forfeiture of all sums paid to BOX.

**Restrictions**

Except as explicitly permitted by BOX, Exhibitor shall not sponsor any hospitality suites/rooms, social functions, education seminars, outings, group activities, or similar events during the Event or distribute sales or promotional materials, any item with Exhibitor’s logo, or gifts to attendee sleeping room doors, meeting rooms or anywhere else in the hotel and/or exhibit facility except in the Exhibitor’s booth space.

All events conducted outside of the exhibit space, including events permitted by BOX, must be contracted through BOX, or BOX’s designee. Exhibitor shall not contract directly with the hotel, its vendors, or other Event venues for any element of a hospitality event.
